1. Privacy Statement

We are aware that you may have concerns over disclosing information about yourself to us.

This Privacy Statement explains, amongst other things, what information we collect about you on this website and the reasons for this.

Overview

Our primary aim in collecting personal information is to provide you with a customised experience on our website (aiming to show you information that is relevant to you) and to provide you with information you have asked for e.g. the location you are submitting from. We also collect information for statistical purposes and, where agreed by you, to offer you products and services that may be of interest to you.

Personal data

Internet security
